Please read each of the following rules of the auction. If you have any questions ask staff before signing this form. IT IS AN AUCTION FACILITATING VEHICLE TRANSACTION BETWEEN BUYERS AND SELLERS. ALL SALES ARE FINAL AND AS/IS!

1. A cash deposit of \$500, along with this registration form is required of all individuals wanting to bid on cars. Each \$500 cash deposit receives only one bidder badge and is good for buying only one vehicle. Any individual who is the highest bidder on a car whether IF or SELL must turn in their badges immediately at the auction block. If you buy a vehicle, the deposit will go directly toward the purchase and the balance must be paid in full before the vehicle is taken off the property. Although payments are accepted the night of the purchase you must pay in full by 1pm Friday. **If you refuse to pay for the vehicle your deposit will be forfeited and will not be returned.** If you do not purchase a vehicle the deposit will be returned to you in cash only after turning in your bidder badge and receipt. **No deposits will be returned to individuals who have a pending IF bid.** No deposits will be returned or go towards the purchase of a vehicle without the original copy of the receipt. Bidding on a vehicle is entering into a contract to purchase.
2. "IF" bids are when a vehicle's high bid does not bring the reserve amount or the seller has given no reserve. The buyer is obligated to the vehicle until the "IF" office has contacted the seller and receives a definite yes or no on the bid. All "IF"s must be decided by 1:00pm the next business day.
3. All vehicles are sold RED LIGHT unless announced GREEN LIGHT by the auctioneer. RED LIGHT vehicles are sold AS/IS and the vehicle cannot be returned for any mechanical reason. All vehicles under \$2000 are AS IS regardless of light. GREEN LIGHT vehicles can go through arbitration for major internal engine and/or transmission problems only with a total repair quote of more than \$500. Arbitrations must be reported within 1 hour of the sale of the vehicle, or 1 hour after the "IF" has been accepted. The decision of the arbitration department is final. Vehicles under \$2000 are not arbitratable and are sold AS IS.
4. Frame damage or odometer problems must be reported within 72 hours of the sale.
5. **TITLE ATTACHED (BLUE LIGHT) means the title has NOT been turned in and the sellers have 45 days to produce the title to the auction.** If the vehicle is sold TITLE ATTACHED the auction does not guarantee the title and the vehicle may have to be returned. If the seller cannot deliver the title, then you can return the vehicle in the same condition you purchased and your payment will be refunded in full for the purchase price only. **THE AUCTION IS NOT RESPONSIBLE FOR MONEY SPENT ON THE VEHICLE ON TITLE ATTACHED TRANSACTIONS.**
6. No one under the age of 14 is allowed on the auction lot or in the auction hall.
7. Be sure you are aware of which vehicle is being sold as vehicles often leave the lane before the final bid. The auction is not responsible for your misunderstanding of what vehicle you are bidding on. If you are unsure, ask the auctioneer before bidding.
8. UPSTATE AUTO AUCTION WILL NOT PROVIDE A 45 DAY TEMPORARY TAG. YOU MUST OBTAIN YOUR OWN TAG FOR A \$5 FROM THE SOUTH CAROLINA DMV AND OBTAIN INSURANCE PRIOR TO DRIVING YOUR VEHICLE. OUT OF STATE RESIDENCE WILL PAY \$20 FOR A 30 DAY TAG.
9. You automatically assume responsibility for any purchase with your bidder badge. If you hand/give your bidder badge to anyone for any reason, then you become responsible for the purchases they make.
10. Vehicles purchased outside the auction block (such as lot purchases) are AS IS. Before an offer can be made you must have a \$500 cash deposit. Offers which have been accepted are final sales. No refunds will be given once an offer is made and accepted. Vehicles must be paid in full by 5pm Friday or the \$500 cash deposit will be forfeited.
